# **Grade 7: Reflective Narrative Conclusions**

• Provide a conclusion that follows from and reflects on the narrated experiences or events.

#### Welcome

Most writers know that a narrative must have a clear beginning, middle, and end. The end of the story can seem obvious; it marks the end of the events or the action. However, it's important to write not just the end of the story but also a conclusion that effectively closes the story, follows logically from the beginning and the middle, and reflects on the experiences or events in the story. A narrative conclusion also offers writers the chance to explain to their readers the overall meaning and purpose of the story. One of the most effective techniques to complete this task is to reflect on the experience. This allows the reader to understand why the story or topic is important to the author, and why it should be important to readers as well. Without a conclusion, the story may end abruptly and leave the reader confused.

**Key Terms** 

- A **conclusion** to a narrative is a final statement, paragraph, or idea. It tells what happens at the end of the story and also effectively closes the essay. It can also analyze, reflect, and explain how the events within the story have affected the main character's life or opinion on the overall topic.
- **Reflection** refers to deep thinking or consideration. Reflective writing explains how past experiences have changed, influenced, or affected the author.

## **Exploring the Standard**

Writing narratives allows writers to make a point through storytelling. While the events in the story may be understandable and relatable, readers often look to the conclusion in order to understand the overall meaning or to make a connection with the writer's personal experiences.

When writing narrative conclusions, writers can ask the following questions as ways to develop a reflective, meaningful, and logical conclusion for their readers.

- What did I learn from the experience?
- How did this experience help shape who I am, or my ideas about the topic?
- What can others take away from my experience?
- How can I use this experience to help me and/or others in the future?

Once the writer answers these questions, he or she can reflect on the experiences and begin to explain the overall significance of the narrative.
